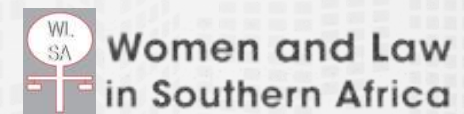

## INTRODUCTION

Zimbabwe grapples with pervasive corruption that undermines governance and development, impacting the achievement of Sustainable Development Goals (SDGs). The country continues to score poorly in governance indices such as the Corruption Perception Index (CPI) and the World Bank Governance Indicator. Corruption affects multiple sectors including human rights, education, land governance, and gender equality.

The National Anti-Corruption Indaba, organized by Transparency International Zimbabwe (TI Z) in partnership with the Zimbabwe Anti-Corruption Commission and the National Prosecuting Authority, aims to provide a platform for various stakeholders to reflect on anti-corruption efforts. This year's theme coincides with the 8th African Anti-Corruption Day, focusing on effective whistleblower protection mechanisms as a critical tool in the fight against corruption.



## OBJECTIVES

- **Main Objective:** To take stock of anti-corruption efforts in Zimbabwe through dialogue on key themes and facilitating jointly owned strategies to strengthen accountability, transparency, and good governance.
- **Specific Objectives:**
  - To influence whistleblower protection laws and policies for safe reporting of corruption.
  - To improve land governance transparency, accountability, and community participation.
  - To develop action plans and recommendations for policymakers, civil society, and private sector stakeholders.

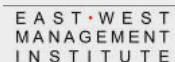
